The research undertaken was not focused on the protected characteristic groups, however, prior to commencement of the project research was undertaken to identify the value of the tourism and the visitor economy to South Cambridgeshire in terms of both the income generated and employment opportunities. The data was gathered via published sources including Visit Britain and the Destination Research report on the Economic Impact of Tourism 2018. Research was also conducted into the methods used by similar and neighbouring local authorities to establish how they promote this part of the local economy and it was identified that South Cambridgeshire is the only district within Cambridgeshire that does not have a stand alone



visitor economy website. This sector has been severely impacted by the restrictions imposed during the pandemic and proactive measures are required to maximise the recovery and increase the potential for capturing the 'staycation' market that will dominate throughout 2021/22. The website will be an asset that can be used to raise the profile and awareness of what South Cambridgeshire has to offer.

See 3.2 above. The research undertaken was not focused on specific groups, however, we are aware of the geography of the district, being predominately villages (100+) and the existence of the new communities and planned future new communities. The rural nature of the district does present challenges in relation to transport for both visitors and potential employees in the sector being promoted alike and the website project intends to address this by including information on rail and bus services and other types of sustainable transport where possible. It is recognised that many of the residents of the emerging new communities may be new to South Cambridgeshire and the website will help to provide information to them that will enable them to become more familiar with the district and all that it has to offer in one easy to use resource. The intention is to showcase a wide variety of attractions, venues and transport options so it is hoped that there will be a broad range to cater for indivduals of all income levels including free of charge.

We have consulted with the Economic Development team at East Cambridgeshire District Council who completed a similar project recently. 5.1 Briefly summarise the key findings of the EqIA and any significant equality considerations that should be taken into account when deciding whether or

The assessment has highlighted that the website must be fully compliant with accessibility standards. This has been built into the process from inception and the webdesigner has committed at tender stage to comply with this requirement. Should it be necessary, printed copies of information held on the site can be requested by individuals who are not able to access the internet. It has also been identified that there may be a requirement to provide the information on request in an alternative language or format such as Braille to ensure that no body is excluded from accessing the information. It is recognised that the geography and rurality of the area can present challenges for some in moving around the area and therefore links to bus and train timetables and other sustainable transport options such as e-bike and e-scooter hire will be included on the website. Where possible we will also provide information in relation to offers such as the rail passes that the government is proposing to launch to encourage sustainable 'staycation' travel options to make journeys more affordable. Recognising that affordability is a key issue for many the site will cover a wide breath of accommodation, attractions and activities, some of which will be free of charge to ensure that it caters to as many people as possible
