The research is based on those households on lower quartile household incomes (nationally published data), and what would be considered an affordable rent based on their household costs. It pulls together existing data on previous rent levels based on pre-covid Local Housing Allowance (LHA) rates and looks at the impacts if Affordable Rents are still based on the current LHA rates which have increased significantly. In drafting this policy,





consultation has been undertaken with both key officers and councillors, before going out to public consultation.

As the impacts of this policy will affect registered housing providers, they will also be consulted separately as part of the public consultation. In drafting the policy, consideration has been given to both the affordability of residents but also the viability for registered housing providers to bring forward affordable housing. The Equality Impact Assessment will be reviewed following the results of the public consultation before final approval of the Policy.

#### 4.2 **Disability**:

Yes. The objective of the policy is to ensure rents are affordable to low income households regardless of disability and therefore will have a positive outcome for those disabled households where their rent is not fully covered by housing benefit or the housing element of Universal Credit. Those with a disability are more likely to experience poverty than able bodied people, and may be more likely to require social housing. [source: <u>Joseph Rowntree</u> <u>Foundation – UK Poverty 2019/20</u>

The English Housing Survey 2017-18 social housing report states that 54% of households in the social rented sector had at least one household member who had a disability or long-term illness, compared to 31% of owner occupiers and 23% of private renters.





The Joseph Rowntree Foundation and English Housing Survey findings both suggest that this policy could have a positive impact on disabled households if they do not receive full housing benefit or the housing element of Universal Credit to cover their rent.
