5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at South Cambridgeshire Hall, Cambourne Business Park, Cambourne, Cambridge, CB23 6EA by 5.00pm on 21 April 2026.

6. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5.00pm on 28 April 2026. Applications can be made online: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
