Thriplow and Heathfield Neighbourhood Plan Referendum Information Statement

Referendum on the Thriplow and Heathfield Neighbourhood Plan

A referendum on the ‘making’ (adoption) of the Thriplow and Heathfield Neighbourhood Plan will be held on **Thursday 12 June 2025** at **Thriplow Village Hall, Middle Street, Thriplow, Royston SG8 7RD** and at **Caravan, Whitehall Gardens, Duxford, CB22 4QL**.

The question that will be asked in the referendum is: “**Do you want South Cambridgeshire District Council to use the neighbourhood plan for Thriplow and Heathfield to help it decide planning applications in the neighbourhood area?**”

The referendum area is identified on the map in figure 1 included at the end of this Information Statement. The referendum area is identical to the neighbourhood area designated in August 2017 for the Thriplow and Heathfield Neighbourhood Plan.

A person is entitled to vote in the referendum if on 12 June 2025:

- he or she is registered and entitled to vote in local council elections;
- he or she is over 18 years old; and
- his or her qualifying address is in the referendum area (shown at figure 1).

The referendum expenses limit that will apply in relation to the referendum is **£2,415.63**. This figure has been calculated based on the electorate for the specified neighbourhood area as at 1 May 2025.

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

The specified documents are:

- the 'Referendum' version of the Thriplow and Heathfield Neighbourhood Plan, which includes a map of Thriplow and Heathfield Neighbourhood Plan area;
- the Examiner's Report on the Thriplow and Heathfield Neighbourhood Plan;
- the written representations on the submission version of the Thriplow and Heathfield Neighbourhood Plan, that were submitted to the independent examiner;
- South Cambridgeshire District Council's decision statement on the receipt of the Examiner's Report and its decision to proceed to referendum, including a statement of satisfaction that the 'Referendum' version of the Neighbourhood Plan meets the Basic Conditions and is legally compliant; and
- a statement that sets out general information as to town and country planning including neighbourhood planning and the referendum.
